Release and Waiver of Liability and Indemnity

IN CONSIDERATION of being permitted to enter for any purpose the locations, facilities and lands of the Mossleigh Gun Club, Thomas David Wark, Iona Marlene Wark, Robert Chadwick Smith, Shelley Marie Smith, or any of them (hereinafter collectively called "MGC"), I, the undersigned, for myself, my personal representatives, heirs, executors, and next of kin, hereby acknowledge and agree that:

1. The use of firearms and other activities at MGC, including traveling to, from and about the locations, facilities and lands of MGC, are potentially dangerous and involve the risk to me or to minors in my charge of serious injury, death or property damage and I agree to assume full responsibility for all such risks.
2. I have read and understand MGC's rules and the MGC Club Safety Rules. I agree to adhere to and abide by the Firearms Act (Canada) and its attendant regulations, the Canadian Firearms Program, the Criminal Code of Canada and such Alberta provincial laws and regulations as are applicable to firearms.
3. MGC, is NOT responsible for any loss, damage or injury suffered by me or by minors in my charge in participating in any activity at MGC, in using the facilities of MGC, participating in any event at MGC or any of them or in traveling to, from or about the location, facilities and lands of MGC, for any reason whatsoever including negligence on the part of MGC, its employees, agents, officers or directors.
4. I hereby relieve, release, waive, indemnify and save harmless MGC, its employees, agents, officers and directors from all or any liability for losses, expenses, damage or injuries which may be suffered by me or by minors in my charge, including liability arising from the negligence of MGC, its employees, agents, officers and directors. This indemnity includes, without limitation, all legal fees that may arise.
5. The forgoing release, waiver and indemnity are intended to be as broad and inclusive as is permitted by the law of the Province of Alberta and if any portion thereof is held invalid, the balance shall, notwithstanding, continue in full legal force and effect. This Release, Waiver of Liability and Indemnity Agreement shall remain in force and from the date of my signing it and shall apply to all of my visits to the Mossleigh Gun Club and the lands it occupies.
6. I have read this document am I am at least 18 years of age and/or I am signing this document as a parent or guardian on behalf of persons less than 18 years of age for whom I am responsible and who may use or be present on MGC premises.
